



#### **Absentee Voting Options for the 2020 Election**

Who Can Vote Absentee? - Every registered voter is eligible to absentee vote

#### Steps to Vote Absentee by Mail

- 1. Apply now for a ballot at the Dorchester County Voter Registration office at 201 Johnston St, in St. George, or request an application for a ballot online at <a href="https://www.scvotes.gov">www.scvotes.gov</a>, or call the Election Commission at 843-563-0132. Be sure to sign it with your name as it appears on your voter registration card. If you can't find your card, go to scvotes.gov and look it up by your county and name. <a href="https://www.warning.gov.org/">warning:</a> applying late puts your ballot at risk of not being returned by the deadline. Apply early and return your ballot asap.
- 2. Ballots will be mailed out beginning in October, if you have not received your ballot by October 15th make sure you call to check the status
- 3. Fill it out and return it by mail ASAP, and ensure to have witness signature.
- 4. Mailed ballots must be received at the county voter registration office by 7 PM on Election Day, November 3, 2020. Because of slower than normal mail delivery in some areas, do not delay. The earlier you return it, the better, if by mail.

#### If you prefer another option besides the United States Postal Service

- 1. You may take your ballot to the Dorchester County Board of Elections in St. George (201 Johnston St.). DO NOT TAKE TO YOUR POLLING PLACE
- 2. If you change your mind and decide to vote Absentee in person rather than by mail, show up during Absentee in person voting hours at the designated location for your precinct. Be sure to have your photo ID.
- 3. <u>The Blue Wave Express</u> is a service of the Dorchester Democratic Party's Voter Outreach, that will securely deliver your ballots to the Board of Elections, in St. George, by Election Day.

## WARNING: Applying late puts your ballot at risk of not being returned by the deadline.

<u>Curbside voting:</u> Available to registered voters who are 65 or older, or who are disabled. Curbside voting is marked at each polling location. You stay in your vehicle and the poll worker comes to you. You will need your photo ID.

#### **Photo ID Requirements**

- ♦ SC Driver's License or ID (Includes standard ID card, REAL ID, and SC Concealed Weapons Permit)
- SC Department of Motor Vehicles ID Card
- ♦ SC Voter Registration Card with Photo
- Federal Military ID (Includes all Department of Defense Photo ID's and Veterans Affairs Benefits Card)
- ♦ US Passport or U.S. Passport ID Card
- ♦ If You Don't Have Photo ID, Free Photo IDs are available at the DMV and your county voter registration and elections office.
- If you can't get a Photo ID, bring your non-photo voter registration card with you to the polls. You will be allowed to vote after signing an affidavit stating you have a reasonable impediment to obtaining Photo ID. The reasonable impediment could be a religious objection to being photographed, a disability or illness, your work schedule, lack of transportation or any other obstacle you find reasonable.
- If you forget to bring your Photo ID with you to vote, you may vote using a provisional ballot that will not count unless you show Photo ID to the county voter registration and elections office prior to certification of the election.
