are on the 2nd & 4th Monday nights at the District Office (815 S. Main St., Summerville) at 6:00 PM. You can find the agenda by going on DD2's web page & click on BoardDocs. It may take a bit of trial & error to find the detailed agenda w/hyperlinks to specific policies to be discussed, etc.

It would be wonderful for SEVERAL DCDP members to attend meetings & become familiar with the Board's workings! Meetings are fairly routine with teachers, students & programs throughout the district being highlighted, updates given on facilities, the status of construction projects, testing scores & analytics, & curriculum changes.

Occasionally there are issues brought up in public comments that are noteworthy. The benefit of having DCDP members engaged is being able to quickly react when the State Dept. of Education makes mandates, when board elections are coming up, & to generally hold the board accountable for their actions.

Meetings are also live streamed & can be watched in real time or later when more convenient. They are also archived so you can go back & watch what has led up to the present.

### **Bill Attacking Diversity, Equity & Inclusion**

South Carolinians have been showing up and speaking out since March 4 against House Bill 3927, a sweeping speech ban that would punish state agencies, schools, and universities for pursuing DEI initiatives. To date, no member of the public has spoken in favor of this bill in a legislative hearing.

On April 1st, sponsors of this bill jammed it through by limiting debate on proposed amendments. Among other things, these amendments would have protected the constitutional rights of South Carolinians and state contractors, promoted equal access to STEM (Science, Technology, Engineering, and Math) programs in schools, and allowed medical professionals to continue DEI training to combat inequities and biases in healthcare.

The majority of lawmakers shot those amendments down and instead adopted a dramatic revision of the bill that targets state contractors for DEI practices. The bill passed the House on Thursday and is now in the Senate, where it has not yet been assigned to committee (as of Weds., 4/9). We can still push back by calling and writing to our state <u>Senators!</u>

#### **Book Censorship Regulation 43-170**

Until last week, the SC Board of Education had been routinely voting to censor books (the most in the country) because of Regulation 43-170. This policy purports to be about "age and developmentally appropriate" classroom materials, but it sets the same standard for kindergartners and 18-year-old high school seniors: Any text containing a "description" of sexual conduct is banned from classroom collections and school libraries.

### **Bills Attacking Transgender Rights**

Several bills filed this spring have targeted the rights of transgender people, particularly trans youth. **Senate Bill 540** seems designed to protect harmful "conversion therapy" practices that falsely claim to change a person's gender identity. The bill, filed April 3, states that a parent or guardian who "seeks out and consents to any lawful mental healthcare service for a child to assist the child in living consistent with the child's sex" cannot be charged with abuse or harm. This bill would send South Carolina in the opposite direction of the 20 states that have passed laws protecting youth from this harmful practice.

**House Bill 4302**, also filed on April 3, would require that children in residential foster care facilities be placed in housing units "based strictly upon the individual's anatomical sex at birth as recognized on their original birth certificate."

In a state where politicians claim to love limited government, our lawmakers keep advancing bills that would create a state-enforced definition of gender — a definition that is notably out of step with science.

#### PARTING SHOTS

The SAVE Act (H.R. 22) - On April 10, 2025, a voter suppression bill passed the US House with a 220-208 vote, and will be taken up by the Senate.

Republicans in Congress introduced the extreme anti-voter Safeguard American Voter Eligibility (SAVE) Act (H.R. 22/S.128) and declared it among their top priorities. This bill would hinder millions of eligible Americans from registering to vote by requiring citizens to present a birth certificate or passport, in person to register.
